

Smartphones promo lottery implementation and organization rules

1. Lottery Description

“MTS Armenia” CJSC (hereinafter referred to as the “Organizer”) is launching a Promo Lottery (hereinafter referred to as Lottery), which will have 27 “iPhone SE” (32 GB) and 54 “Honor 9 Lite” smartphones as prizes. The Lottery is implemented by means of software developed by “MTS Armenia” CJSC.

2. Name and Legal Address of the Lottery Organizer

“MTS Armenia” CJSC, 4/1 Argishti Street, 0015, Yerevan, Republic of Armenia

3. Lottery Participants

Physical entities (with the exception of “MTS Armenia” CJSC and “MobiDram” CJSC employees) are eligible for participation in the Lottery. Legal entities cannot participate in the Lottery.

4. Lottery Implementation Order

4.1. To participate in the Lottery the participant shall from October 1, 2018 till October 30 (inclusively) purchase in cash or by installment (by bank transfer only) any smartphone at “MTS Armenia” CJSC service centers. While purchasing the smartphone, the participant has to provide to the Organizer his or her contact phone number for the Organizer to be able to contact the participant in case of victory. Upon the completion of the purchase the participant shall retain (shall not sell, donate, or in any way alienate) the purchased smartphone and the cash receipt (payment receipt).

4.2. The Lotteries for the smartphones mentioned in Point 1 of this Rules will be implemented by means of software developed by “MTS Armenia” CJSC starting from October 2, 2018 till November 1, 2018. Lotteries for the smartphones, bought on Saturday or Sunday during the mentioned period, will be implemented on the following working day. The IMEI codes of the smartphones purchased on the day preceding the day of the Lottery will participate in each Lottery, and the IMEI codes of the smartphones purchased by the winning participants will be randomly selected and publicized.

4.3. The publication of the results will be available online (on “MTS Armenia” CJSC [official Facebook page](#)). The results will be publicized at 11:00 AM on each Lottery day, and the results of the Lotteries for smartphones, bought on Saturday or Sunday - at 21:00 PM on the following working day. The appropriate link will be published on www.mts.am, the official website of the Organizer, on October 1, 2018.

4.4. To receive the prize, the winning participant shall visit “MTS Armenia” CJSC service center, from which the smartphone was purchased, within 7 calendar days starting from the day of publishing the results of each Lottery. The winning participant shall submit personal identification

document (passport or identification card), the smartphone, the IMEI code of which was selected as winner during the Lottery, and the cash receipt (payment receipt) of the purchase.

4.5. In case the winning participant does not visit “MTS Armenia” CJSC service center as stipulated in Point 4.4. of these Rules, does not submit the documents, the purchased smartphone, or the cash receipt (payment receipt), as stipulated by the same point of the Rules, within the set period of time, the results of the Lottery for the given win shall be deemed void; an appropriate information on that will be published on the Organizer’s official webpage on www.mts.am within two working days after the deadline mentioned in Point 4.4. of these Rules.

4.6. In case of termination of the Lottery, the Organizer shall publicize information on the termination on its official website www.mts.am or otherwise publicly inform the participants about it.

5. Other Terms

5.1. Participation in the Lottery (including submission of information, getting the prize in case of victory and other terms stipulated in Point 4.1. of these Rules) are considered as unconditional acceptance of these Rules by the participant.

5.2. These Rules, further amendments in them (if any) and the full information about the Lottery are published on the Organizer’s official website www.mts.am.

5.3. Since, with the purpose of providing transparency of the Lottery, the identification data of participants (name, surname, passport details, etc.) are not registered in the Organizer’s systems before the moment of handing over the prize, and since the selection of the winning participant is performed based on random selection of the smartphone IMEI code, the Organizer does not anyhow bear responsibility for possible conflicts between the person who actually purchases the winning smartphone and the person who visits the headquarters of the Organizer as per Point 4.4. of these Rules. In all cases, the winner of the Lottery is the person who visits the service center of the Organizer according to the terms stipulated in Point 4.4. of these Rules.
